State Laws Addressing Doula Scope of Practice

Increasing access to safe and effective doula care could decrease the high maternal morbidity and mortality rate in the United States. Doula services are woefully underutilized, as only about six to 10 percent of births in the country involve a doula.¹ Lack of coverage for doula services from both private and public health insurance functionally limits access to doula care principally to those who can afford the services out-of-pocket.² The narrow ability to make a living as a doula suppresses the number of doulas available and the racial and ethnic diversity of doulas. Understanding how state regulation of doula certification, care, and coverage affects availability of and access to doula services can shed light on opportunities and challenges to using doulas to improve maternal health outcomes.
